STANDARD OPERATING PROCEDURE (A)

Standard Operating Procedure to be followed for appointment of Assistant Professors on regular basis at the University Campus, its Regional Campuses Constituent and University Colleges

- 1. Online applications on the prescribed format shall be invited from the eligible candidates for the posts of Assistant Professors through an open advertisement to be published in newspapers as well as posted on the University website (www.gndu.ac.in).
- 2. The applicants will be required to fill up the Score Card Proforma(as per Annexure-II) duly approved by the Syndicate, available at www.gndu.ac.in.
- 3. The shortlisting committee will consist of Director Research as a Chairperson and Board of Control of the Concerned Department.
- 4. After receipt of applications, shortlisting of the applications shall be done by the shortlisting committee(as per the criteria specified in Annexure-I) to check the documents as well as eligibility of the applicants.
- 5. The shortlisting committee will verify the marks claimed by the applicant in the Score Card and prepare a merit list based on the Score Card.
- 6. The shortlisting committee shall also send recommendation to invite 6 candidates for each first vacancy and 3 candidates for every additional vacancy (as approved by the Syndicate) for the interview as per the order of the merit list.
- 7. The constitution of the Selection Committee shall be as per UGC Regulations 2018 under Clause 5.0 and sub clause 5.1(I) for appointments on regular basis. At least four members, including two external subject experts shall constitute the quorum.
- 8. The final Selection of the candidates will be made by the Selection Committee considering the following parameters as per Annexure-II(a):
 - a) Academic Record and Research Performance and Teaching Experience/Post Doctoral Experience and Awards [as per score card attached at Annexure II, the marks secured by applicant as per annexure-II will be calculated for 60% weightage of 100 marks by applying the formula =

Marks secured x 60

Maximum marks (100)

- b) Assessment of domain knowledge by external experts(in a simulated class room set up) 20 % weightage
- c) Interview 20% weightage

All the applications received shall be scrutinized by the Shortlisting Committee and a list of all the candidates fulfilling the minimum eligibility qualifications as per "UGC Regulation on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education" of 2018, shall be prepared and points be awarded to all such candidates shall be calculated on the basis of the above criteria.

- 1. After allocation of points to all the eligible candidates, the Shortlisting Committee will draw a list of all candidates indicating the points scored by them in descending order i.e. starting from the candidate getting the highest points.
- 2. In case of tie in the points of two or more candidates, the candidates having the higher/highest marks at the Master's level shall be ranked above the other (s).
- 3. For each first vacancy 6 candidates will be called for interview and assessment of Domain Knowledge according to Merit and 3 candidates for every additional vacancy. In case the required number of application are not received then the minimum number of applicants to be invited for interview shall be decided by the Vice- Chancellor.
- 4. The Points awarded to the candidates during the process of shortlisting of applications shall be used for selection process and in interview by the Selection Committee.
- 5. The Period taken by candidates to acquire Ph.D shall not be considered as teaching / research experience to be claimed for shortlisting /appointment.
- 6. The University shall display the criteria for shortlisting of applications on its website.
- 7. In case of any dispute with regard to shortlisting of applications, the decision of the University shall be final.
